Update on the Progress of the Discussion Relating to the Proposed Memorandum of Mutual Recognition of Membership (MMRM) between the GPD and its RICS counterpart

As a follow-up to the progress report made in the Chairman's Message last month, the Working Group met with its RICS counterpart on 15 January to further discuss mutual recognition between the two.

Both agreed that any professional who fails an assessment with one body, but subsequently passes that of the other body, may use the MMRM to access the first body. Probationers of one body who have not yet completed their APCs or members of one body who have not yet become probationers of the other body can also use the MMRM to access the other body. The GPD Council has no comment on the RICS's proposal to include the words, "(including those under the classification of the previous General Practice Division)," after the words, "Chartered Valuation Surveyor," in Lines 2 and 3 of the second paragraph of the salient conditions of the proposed MMRM, as set out in Paragraph 2 of the progress report in the November 2017 Chairman's Message.

We submitted the revised MMRM draft, as aforesaid, to the General Council for its records on 25 January. The Working Group shall then work with its RICS counterpart to reach an agreement on the logistics, including the details of the interviews and joint publicity, with a view to signing the MMRM in February or March. The MMRM should tentatively become effective on 1 April 2018, subject to RICS agreement.

The GPD Council shall update members on the progress of the discussions through formal announcements and in future issues of *Surveyors Times*.

A New Move

WAVO President Prof LIM reported the signing of the Memorandum of Collaboration (MOC) with the IVSC in November 2016, after which WAVO launched various training courses on the new IVS in 2017. He also informed the Board that per the IVSC's request, WAVO will jointly organise an international congress on valuation with the IVSC in May or June 2018. The congress' overall theme will concentrate on the evolution of and new trends in the valuation profession. It will be conducted via different plenary sessions and technical workshops. The WAVO Secretariat will work out the details and inform WAVO members in due course.

Proposed Amendment to the WAVO Constitution

The Board Meeting also reviewed the issues related to membership growth and its role after the MOC. Following the discussions in the last two board meetings, Sr Edward AU presented a paper that reviewed WAVO membership, voting rights, and the construction of the WAVO organisation. After deliberations, the WAVO Board decided to maintain the status quo on voting rights, but chose to expand the number of WAVO Board members. Besides, in order to maintain the consistency of WAVO's policies and mission, the Board also agreed to set up an ex-officio governing council to oversee the operations and development of WAVO's business. Ex-officio members will be nominated from senior WAVO members who, in their personal capacities, will serve in the proposed ex-officio governing council. This proposal will be formally decided on during the 2018 WAVO AGM.

WAVO Certificate for Valuers

Membership growth has been a major topic in recent years. Mr Reiner Lux, Chairman of HypZert during the last Board Meeting held in June 2017, proposed that a WAVO designation be granted to qualified valuers of member associations or individual WAVO members. He presented a WAVO Certificate scheme during the Board Meeting and stated that its main theme was to create an international valuation expert network. Such an internationally recognised designation of valuation professionals would bring about an increased awareness of WAVO and recruit new members.

The Board decided to introduce a new designation of "WAVO-Recognised Valuers" for individual members or those who belong to member associations. Both could register their qualifications with WAVO and be designated WAVO ReVs (WAVO Recognised Valuers). HypZert will finalise the detailed proposal for discussion at the next AGM.

WAVO Workshop 2017

Following the WAVO Board Meeting, a one-day workshop was jointly-hosted by WAVO and SISV and focused on "Evolving Trends in Valuation". Speakers from the US, Australia, Hong Kong, Romania, and New Zealand shared their expert views on the following topics:

"AVM, BPO's, and Evaluation vs Appraisals: a US Perspective" "Advancing Technology: Friend or Foe to the Valuation Profession?" "Trend of Valuation in Hong Kong: View from the Top" "Evolving Trends in Valuation in India"

The workshop was well-attended by valuers from around the world and SISV members.

Invitation for Speakers -HKIS General Practice Division PRE-QUALIFICATION STRUCTURED LEARNING PROGRAMME (SLP)

In accordance with Section 6 of the APC Rules and Guide promulgated in June 2012, candidates are required to attend a mandatory 40-hour pre-qualification structured learning programme before they can attempt the Part I Assessment. For the purpose of meeting this APC requirement, the GPD Education Committee will organise a 17-session (51 hrs) SLP for the candidates. The SLP aims to equip the APC candidates with an understanding of the practical application aspects of the GP surveying industry. Candidates are expected to attend at least 40 hours out of this 51hour programme.
