
# Debriefing and Sharing of the HKCSS Community Housing Movement (CHM)

The BSD's Building Surveying Volunteer Team (BSVT) completed a meaningful task last year by delivering preliminary inspection services to around 100 domestic flats for the Community Housing Movement (CHM) Project organised by the Hong Kong Council of Social Services (HKCSS). On 18 September, the BSD held a debriefing and sharing session for all volunteers. I was glad to have Mr Charles HO Chun Kit, the CHM Project Director, join this debriefing session to share with us his ideas, the difficulties of implementing the project, and the task of matching tenants to flats.

Charles also briefed the volunteers on the project's interim results and future plans. They learnt that over 220 flats were decorated to accept over 600 tenants. I am proud of our volunteers for donating their professional skills to this project, which serves and connects society's neediest members.

The BSD's Honorary Secretary, Sr Peter Dy, who also coordinates the BSVT, also shared with the volunteers some memorable moments and interesting findings during the course of its inspections. After the debriefing, I presented certificates of appreciation to all volunteers to acknowledge their kind contributions. My heartfelt thanks go to all core members, team leaders, and volunteers for their invaluable inputs!









# Updates and Experience-Sharing on AP(S) Practice Issues

On 27 September, Sr Arthur Cheung, Sr Vincent Ho, and I held a CPD event to deliver updates and share experiences on authorised person practice issues. We also invited a Buildings Department (BD) representative to present the details of the electronic form submission and authorised person registration systems. He announced that there were only 232 surveyors on the authorised person register, which was low compared to the 1,216 architects listed. This also meant that only 17% of the Institute's professional members have qualified to be authorised persons. Hence, I encourage more building surveyors who qualify to apply to be listed on the register, so as to meet market demand.

After that, we shared the latest updates on MiC, a new JPN concerning building height restrictions, the Code of Practice on Design for Safety – External Maintenance, BIM submissions, APSEC updates, draft papers from the BD, etc. The subsequent Q&A session featured interactive exchanges. The BSD encourages members to share their AP practice-related problems and make enquiries at BSDForum2018@gmail.com. Its APSEC convener, Sr Arthur Cheung, will consolidate the issues and discuss them during the APSEC discussion forum that the BD regularly conducts.

On 10 September, the BSD held a CPD on the topic of Fire Engineering Design on Tai Kwun. It invited Ir Anny Ip, Associate Director of Ove Arup who has been involved in this challenging project since 2007, to deliver a fruitful presentation to members.

Tai Kwun is currently the largest remaining compound of historic buildings and represents the earliest examples of law and order in Hong Kong. By using a fire engineering approach, Ove Arup proposed practical improvement measures to achieve acceptable fire safety standards in the buildings that successfully overcame the challenges of non-compliant fire safety issues such as too-narrow and unprotected exit staircases, the non-provision of required downstands surrounding floor voids, etc. After this CPD event, I believe all attendees gained a lot of practical knowledge to apply to their fire engineering designs for adaptive re-use.





# Seminar for Estate Agent Authority (EAA)

On 28 September, I was invited by the EAA to deliver a talk to its members. My topic concerned problems with unauthorised building works (UBWs) that estate agents, property owners, and tenants should heed. The EAA also invited lawyers and bankers to share their professional knowledge of and experiences with legal issues, insurance coverage, and mortgages. The talk received positive feedback from the floor, which had many questions about the statutory requirements of open kitchens, rooftop structures, internal staircases, and building orders, as well as the impact of UBWs on mortgages, insurance, etc. I also took the chance to introduce the BSD's proposal to conduct pre-acquisition surveys of second-hand domestic flats and how this helps prospective property buyers and improves building safety.

# Briefing Session on PNAP APP-161 and PNAP ADV-36 for Modular Integrated Construction (MiC)

In order to promote the wider use of MiC, the BD has issued PNAP APP-161 and PNAP ADV-36 regarding the granting of GFA concessions and their implementation details. A briefing session was held on 16 September for building professionals and industry stakeholders. This event was very informative and the BD speaker clearly conveyed the details of the PNAPs, which included, but were not limited to, the criteria and benefits of MiC, GFA concession conditions, timelines, pre-submission enquiry services, pre-acceptance mechanisms of MiC systems or prototypes, quality supervision, etc. Since MiC is a new trend in the building industry for promoting sustainability, site safety, and efficient and better quality control, building surveyors should familiarise themselves with it. The BSD has already jointly set up a task force with the QSD on MiC to prepare some guidelines and best practices, as well as arrange CPD events and site visits to MiC projects for members in the near future.

# Luncheon with the Construction Industry Council (CIC)

On 26 September, Sr Daniel Hui and I represented the HKIS at a luncheon with some CIC members, committee members, and other institutional representatives to discuss the latest developments in site safety and quality control in the construction industry. During the luncheon, the CIC introduced a newly-established Safety Experience Training Centre located at the HKIC Kwai Chung Campus. The Centre is about 3,000 square feet in size and equipped with various facilities for simulating real work environments in a virtual reality setting. It features eight different training zones that deal with common accident types in the construction industry such as working at great heights, lifting and rigging plants, etc. Members can patronise the centre to receive safety training.





#### HKIS Annual Conference 2019

The HKIS invited me to moderate a morning session of its Annual Conference 2019 at the JW Marriott Hong Kong on 21 September. The conference's theme this year was "Innovation: Revitalising Construction". The morning session's topics included PPVC in Singapore, common spatial data infrastructure, 3D digital mapping, and building design for safe external maintenance, all of which are currently hot topics in the industry. I was glad to witness an interactive Q&A session afterwards.









# Create Your District 2019: First Screening of 3D Models and the Multimedia Category

There was an open competition to build 3D models and multimedia presentations for the Create Your District (CYD) 2019 event, which is an HKIS 35th anniversary event specially designed for secondary school students. The selected district for CYD 2019 was Tsim Sha Tsui. As a juror for this competition, I joined the first screening of entries at the HKIS's head office on 25 September. I was surprised by the high quality and creativity of the submitted 3D models, videos, and story maps. Most entries reflected real life problems with suggested solutions to better develop Tsim Sha Tsui and how surveyors can play a role in this. A jury assessment of the selected entries will be held on 12 October 2019.





## HKIS 35th Anniversary Run: Runderful Pro

The HKIS 35th Anniversary Run, Runderful Pro, was successfully held at the Science Park on 15 September. This was the first running event organised by the HKIS and it attracted over 700 runners.
