However, the QSD reserves the right to remove any firm/company from the List if such firm/company is discovered not to have fulfilled the abovementioned requirements or where the sole proprietor/partner/director of the firm/company has been found by the Disciplinary Board of the HKIS to have contravened the HKIS's Rules of Conduct or any provisions of the HKIS's Bye-Laws.

Firms/companies wishing to be listed have to declare annually that they fulfil the requirements of the aforesaid requirements by completing this Declaration Form, and inform the QSD of any changes which may render them unable to fulfill the said requirements within one month after the changes are made known to them.
