PRESIDENT'S MESSAGE 會長的語



Sr Paul WONG

was honoured to represent the HKIS at the morning flag-raising at Golden Bauhinia Square on 1 October, this year's National Day marking the People's Republic of China's 74th anniversary.

My schedule has been packed with other events: the Executive Council Monthly Luncheon on 12 October, City University of Hong Kong Foundation Dinner on 20 October, the Planning and Development Division Annual Dinner on 27 October, the Young Surveyors Group Annual Dinner the next evening, and other institutes' collaborative events.

Safety paramount

Recent deaths and serious injuries among construction workers have heightened safety concerns in the industry. The Government's response—moving to strike a contractor from the Buildings Department (BD) registration list—signals penalties will no longer be confined to fines or suspension from tendering. To underscore safety's importance to the Institute, I recently participated in several safety-related events and shared views on site safety, including in a Metro Radio interview on 24 October.

The Housing Authority's "Safety Forum 2023 for Works and Property Management Services" on 28 September allowed for a comprehensive examination of safety and enabled practitioners to better understand the Government's ideas on safety.

I attended the BD's Building Safety Symposium, themed "Expanding Opportunities for a Safer and More Sustainable Built Environment", on 27 October. I also exchanged views on site safety and the Authorised Signatory system with the Director of Buildings, Ms Clarice Yu.

I also attended the Construction Industry Council's Kickoff Seminar for the Workshops on Construction Robots on 5 October. This fascinating event showcased advanced construction robots locally and worldwide and identified potential robotic construction as a key to a safer and more efficient sector.

Policy Address 2023

On 3 October, the HKIS made 10 suggestions to Chief Executive John Lee Ka-chiu for his Policy Address 2023, expressing our continuing concerns about construction, housing and land policy development. We followed this with a press conference and press release on 20 October. I also aired in a Metro Radio interview various suggestions raised by the HKIS on 24 October.

The HKIS is grateful to see its various suggestions incorporated in the Government's stated determination to solve social issues related to building, housing and land policies in the Policy Address 2023 and supported the overall direction with suggestions on 25 October.

Regarding housing policy, the Government accepted our suggestion to fine-tune Buyer's Stamp Duty to attract non-local talent to settle in Hong Kong: they no longer need to pay the refundable duty at the time of purchase. The HKIS also welcomes shortening the applicable period of Special Stamp Duty from three to two years and halving the Buyer's Stamp Duty rate from 15% to 7.5%.

With land policy, we are in lock-step on standardising land premiums to expedite the

development and use of land, especially idle land and industrial buildings.

Regarding building safety, the Buildings Ordinance is to be amended, and prosecutions made more streamlined and from a lower threshold. The HKIS hopes for fixed penalties that might push owners to carry out maintenance works and rectify unauthorised building works.

Continuous connection with the Mainland

I joined a high-level HKSAR delegation of 70 headed by the Chief Executive, Mr John Lee, to Beijing for the third Belt and Road Forum for International Cooperation on 17–19 October. On 18 October, I attended a parallel forum on Sub-national Cooperation, which included a session dedicated to Hong Kong: "A Hong Kong Chapter". It shared and promoted our city's strengths, how Hong Kong enterprises tap business opportunities, provide services, and their professionalism and roles in high-quality Belt and Road developments.

I delivered a speech at the 5th Guangdong-Hong Kong-Macao Greater Bay Area Modern Property Service Industry Innovative Development Forum held in Shenzhen on 13 October. I raised the importance of collaboration to develop more creative ideas, closer partnerships and cooperation to make property facility management more efficient in the Greater Bay Area.

Meet and greet

Autumn is the peak annual conference season. I delivered welcome speeches for the Building Surveying Division Annual Conference, themed "Impact on Built Assets: Proactive Maintenance and Rehabilitation", on 13 October, and the Quantity Surveying Division Conference, themed "Mapping the Future of the Built Environment:

The Roles of Quantity Surveyors", on 28 October.

There was a strong international flavour to the Land Surveying Division Conference, themed "Connecting the City with Geospatial Intelligence", on 14 October, with guest speakers from the Singapore Institute of Surveyors and Valuers and the Land Surveyors Board Malaysia. Two days later, both organisations visited the HKIS to discuss closer collaboration.

These three divisional conferences provided valuable opportunities in tirelessly promoting the pivotal roles of surveyors in Hong Kong's development.

Giving back to society

My heartfelt congratulations to the secondary school student winners of the HKIS "Create Your District Competition 2023" and thanks to the Secretary for Development, Ms Bernadette Linn, JP, who presented the awards on 21 October. Ms Linn also spoke on the construction of the 15-minute city in the proposed Northern Metropolis. I was impressed by the students' high-quality presentations. We hope the industry can find ways to tap these students as future new blood for the surveying profession.

I also gave opinions on other industry issues: the setting up of tree-top adventure facilities to give visitors a more varied experience in country parks, for the Agriculture, Fisheries and Conservation Department on 5 October; and the manpower requirement projection consultation for the Census and Statistics Department on 26 October.

PRESIDENT'S MESSAGE 會長的話

1 月1日早上,我有幸代表香港測量師學會(下稱學會)參加了在金紫荊廣場舉行的升國旗儀式,慶祝中華人民共和國74週年國慶日。

今個月的行程仍然非常緊凑,我參加了多個活動,包括 10 月 12 日的行政會議每月定期午餐會、10 月 20 日的香港城市大學基金晚宴、10 月 27 日的規劃及發展組周年晚宴、10 月 28 日的青年組周年晚宴以及其他學會的交流活動。

安全至上

近期建築工人工業意外和嚴重受傷事件加劇了行業對安全的擔憂。政府最近的回應——將涉事承建商從「一般建築承建商名冊」中除名,這表明處罰將不再局限於罰款或暫停投標。為了強調安全對學會的重要性,我最近參加了幾個與安全相關的活動,並在 10 月 24 日的新城電台訪問中分享了對工地安全的看法。

屋署於 9 月 28 日舉辦的「工程和物業管理安全研討會 2023」,全面探討了安全問題,並讓從業人員更好地瞭解政府對安全的理念。

我在 10 月 27 日參加了屋宇署舉辦的「樓宇安全研討會」,主題是「攜手開拓機遇締造安全及持續的建築環境」。此外,也與屋宇署署長余寶美女士太平紳士就工地安全和屋宇署獲授權簽署人制度交換了意見。

10月5日,我還參加了建造業議會舉辦的「建築機械人工作坊啟動研討會」。這個富啟發性的活動展示了本地和世界各地先進的建築機器人,並發掘機器人應用之潛力,令行業未來發展得更安全、更高效。

2023 施政報告

學會在 10 月 3 日向行政長官李家超先生提出了 10 項建議,表達了我們對建築、房屋和土地政策

發展的持續關注。在 10 月 20 日,我們舉行了新聞發佈會及於新聞稿中進一步強調了有關建議。在 10 月 24 日的新城電台採訪中我就學會提出的各種建議發表了意見。

學會對政府在《2023 年施政報告》中採納我們各項建議及其堅定解決與建築、房屋和土地政策相關的社會問題表示歡迎,並於10月25日發佈新聞稿回應支持整體方向並提出一些建議。

關於房屋政策,政府接納了我們的建議,調整買家印花税,以吸引外地人才到香港發展:他們不再需要在購房時支付可退還的印花税。學會還歡迎將額外印花税適用年期由三年縮短至兩年,同時將買家印花税税率從15%降低到7.5%。

在土地政策方面,學會對政府擴大標準化補地價 安排表示支持。這項安排有助加快土地發展和利 用,特別是閒置土地和工廈。

關於建築安全問題,《建築物條例》將會進行修訂,學會歡迎簡化檢控程序、降低檢控門檻和加強 罰則。我們亦希望政府能夠採用定額罰款的方式, 更有效地推動業主進行樓宇維修及處理僭建物。

與內地持續聯繫

我參加了由行政長官李家超先生率領的70人高規格香港特別行政區代表團,於10月17日至19日赴北京參加第三屆「一帶一路」國際合作高峰論壇。在10月18日,我出席了以「地方合作」為專題的平行論壇,當中包括一場專門討論香港的環節:「香港專場」。論壇分享和推廣了本港的優勢、企業如何利用商機、提供專業服務,以及企業在高質量的「一帶一路」建設中的作用。

10月13日,我於深圳舉行的「第五屆粵港澳大灣區物業管理創新發展論壇」上發表了演講,強調粵港澳大灣區合作的重要性,籍開發更多創意思路,建立更緊密的夥伴關係和合作,從而提高大灣區物業設施管理的效率。

秋季一向是舉辦年度研討會的高峰期。 我分別於 10月13日及10月28日為建築測量組主題為「積極保養與復修對建築資產的影響」和工料測量組主題為「工料測量:構建未來一探索工料測量前景助城市發展」的周年研討會發表了歡迎辭。

10月14日,土地測量組舉行主題為「將城市連接起來:地理空間智能」的研討會,邀請了來自新加坡測量師與估價師學會(SISV)和 Land Surveyors Board Malaysia 的嘉賓演講。10月16日,這兩個組織到訪了學會,討論更緊密的合作事宜。

以上三個組別的研討會成為推動測量師在香港發展中的關鍵角色,努力地提供了寶貴的機會。

回饋社會

我衷心祝賀學會「構建『你』想北部都會區」 創作比賽 2023 獲獎的中學生,並感謝發展局局長 甯漢豪女士太平紳士在 10 月 21 日的典禮上頒發 獎項。甯局長還就北部都會區的 15 分鐘生活圈發 展建議發表了講話。學生們高質素的參賽作品和面試表現令我印象深刻。我們希望業界能夠找到方法從這些學生中吸納成為未來測量專業人才。

本月我另就其他行業問題提出了意見,包括在 10 月 5 日就漁農自然護理署為郊野公園設立樹頂歷奇設施以豐富市民體驗的諮詢作出建議的問題,以及在 10 月 26 日為政府統計處的人力資源推算咨詢提供了意見。

Surveyors Welcome 2023 Policy Address

The Hong Kong Institute of Surveyors has responded positively to the Chief Executive's Policy Address, announced on 25 October, which addresses Hong Kong's current challenges and promotes future development. The Policy Address has incorporated insights from HKIS as well as market needs to seek improvement on housing, land, building and construction. The Institute hopes that the government will continue to step up collaborative efforts with professional bodies and stakeholders to implement the initiatives.

Unleashing development potential of land

Sr LAU Chun-kong, Past President and Chairman of Land Policy Panel of the HKIS, is glad that the government will speed up land production and development by streamlining statutory and administrative procedures. The Chief Executive has accepted HKIS proposals over the years to expedite disbursement of land resumption compensation, relax gross floor area exemption for aboveground carparks to speed up development process, extend arrangement for standardisation of land premium to cover industrial buildings for special uses completed before 1987 and to introduce pilot scheme to agricultural land in the New Territories.

The Policy Address mentions revitalisation of Hung Hom Station and nearby sites, as well as development of ex-Lamma Quarry site. "The HKIS has been advocating unleashing potentials of idle land for years. Apart from planning and studies, I hope the government will announce concrete implementation plans soon. There are more idle lands than those mentioned in the Address. Follow-up actions are needed."

Sr Lau is particularly enthusiastic as the government will extend the Enhanced Conventional New Town Approach to all New Development Areas. This includes applying land exchange arrangements to designated sites for industries and private community / welfare facilities, facilitating landowners owning 90% or above of private land within a development site to carry out consolidated development. "In

the past, developers had problems acquiring all pieces of private lands within a planned development site, for example due to land ownership issues regarding Tso / Tong lands." He thus considers consolidated development most encouraging. With government's facilitation on the policy level, he believes surveyors can help explore the details with the government.

Sr Lau welcomes the Major Transport Infrastructure Development Blueprint that is to be announced. "The Northern Link Eastern Extension and the Northeast New Territories Line etc are all crucial in establishing a web-shaped transportation system to give users increased flexibility, especially when certain routes are somehow disrupted by accidents or unexpected events." He is delighted to see proposals for better connections in Kwun Tong uphill areas, Kai Tak, and Hung Shui Kiu.

HKIS recommends that the government further explain to the public how the Kau Yi Chau Artificial Islands and the Northern Metropolis development mean overall improved transportation network in Hong Kong. The Chief Executive responds by setting up a gallery to showcase the projects.

As for addressing talent shortage, he believes the stamp duty adjustments are timely to help attract talents. Sustainability issues are also addressed via promotion of electric private cars. More can be done as electric cars represent just more than 64% of new registration in Hong Kong in the first eight months of this year.

Major improvements on building standards

Sr HO Kui-yip, Vincent, Past President and Chairman of Building Policy Panel of the HKIS, is pleased to see that the Chief Executive proposes setting up a Task Force on Tackling the Issue of Subdivided Units (SDUs) to address the problem. The HKIS has been giving recommendations for setting standards to regulate SDUs, eradicating substandard ones, and giving grace periods to owners to make improvements. He hopes the Task Force will be

a consolidated body bringing together multiple government departments concerning buildings, housing, home affairs and social welfare, so as to plan and implement policies ranging from building standards to relocation of residents.

"Stepping up eradication actions for SDUs could mean killing two birds with one stone, as the removal of problematic SDUs could help solve drainage and water seepage issues, tackle illegal works, enhance maintenance and overall well-being of buildings."

The Chief Executive has accepted HKIS' recommendations to amend the Buildings Ordinance to streamline prosecution procedures, lower prosecution threshold, raise penalties against unauthorised building works (UBWs), non-compliance cases of mandatory building inspections and repairs and other statutory orders, and to strengthen registration system of contractors to enhance professionalism. On top, Sr Ho hopes that the government will set up fixed fines against individual owners related to failure to conduct mandatory building inspection and repair to the common parts of their building, rather than owners' corporations, such that owners would rather pay for the inspection and repair and removal of UBWs than be penalised. Since owners are often reluctant to finance maintenance for common parts of buildings. fixed fines would be especially effective to raise compliance rates.

Whereas the HKIS recommends that the government set up a Building Repair Authority and require building corporations to establish a Sinking Fund as a maintenance fund, these recommendations have not been incorporated into the Policy Address. Elaborating on the recommendations, Sr Ho explains that the proposed Authority can assume the role of a project manager or a reliable and high-level body to take over inspection and repair work from tender invitation to completion. Entrusted by owners, the Authority will be paid an additional fee to complete the tasks to enhance efficiency and standard procedures.

The Authority could collectively regulate and manage the proposed pool of Sinking Fund. The Fund, coming from a proportion of the monthly property management fee of buildings with the purpose to fund future maintenance and repair works, helps avoid compromising building safety when residents are unable to afford associated costs. "The Fund, just like health insurance, should be set up as quickly as possible as ageing buildings need maintenance. Collectively managed by the Authority, it avoids misuse or misunderstandings among owners' corporations and residents."

Sr Ho expresses disappointment as HKIS' proposal to promote pre-purchase inspection of second-hand residential properties to identify UBWs has not been included in the Policy Address. He hopes maintenance and repair



can start from individual owners and buyers. who would have gained a comprehensive understanding of potential liabilities from the proposed pre-purchase inspection. Prepurchase inspection could mean high-level sampling and monitoring to gradually achieve overall building safety of the entire city.

HKIS' proposal to make 'keeping' of UBWs as a criminal offense, subject to penalties, has not become part of the Policy Address either. Sr Ho has hoped that the forward-looking proposal could help establish a 'clean-up' culture to eradicate UBWs and truncate their succession to subsequent owners.

He welcomes the government initiative to grant Gross Floor Area concessions for aboveground car parks in private residential buildings, elderly-friendly building designs, and drainage improvement works in view of extreme weather conditions.

Responding to market demands regarding properties

Sr CHIU Kam-kuen, Immediate Past President and Chairman of Housing Policy Panel of the HKIS, has positive views towards the Policy Address. "Regarding private residential properties, the Chief Executive has positively responded to market needs by shortening the applicable period of Special Stamp Duty (SSD) from three years to two years. Rates of Buyers Stamp Duty (BSD) and New Residential Stamp Duty (NRSD) will be reduced from 15% to 7.5%. For incoming talents who acquire residential properties, the stamp duty may be suspended at the time of property acquisition but the talent is required to pay relevant amount if subsequently unable to become a permanent resident." With the belief that reduction will stabilise the property market and help buyers regain confidence, Sr Chiu hopes administrative measures will be further reduced to enable a market-driven property market.

For young people to own properties without being stigmatised, he advocates that the

government refer to Affordable Housing abroad that requires private developers to allocate a certain proportion of private housing at a discount price.

As for public and subsidised housing, the Chief Executive has not incorporated HKIS' specific recommendations to tighten Well-of Tenant Policies, lower threshold for paying additional rent, adjust rent payable to three to four times the normal rent, lower income and asset limits. and halt the Green Form Subsidised Home Ownership Scheme to prevent units from flowing into the open market. Despite this, Sr Chiu believes the government should continue implementing measures in place such as requiring tenants to declare financial conditions every two years to avoid abuse of public resources.

To maintain stable stocks of available rental and subsidised units, he believes Home Ownership Scheme flats sold in the future should only be allowed to be sold to a nominee by the Housing Authority, and they should not be sold in the open market through land premium. To help circulation of old subsidised sale flats (SSFs), he welcomes the measure to extend mortgage default guarantee period for SSFs from 30 years to 50 years so that purchasers may have mortgage loans of longer tenor.

HKIS recommendations adopted

Overall, the surveyors are extremely pleased that the Policy Address has adopted many of HKIS' recommendations made over the years. Apart from the above, the HKIS welcomes initiatives to lower compulsory sale application thresholds for facilitation of urban renewal, the Pilot Programme on Community Living Room, and the Action Agenda for the Northern Metropolis etc.

測量師對《2023施政報告》表示歡迎

香港測量師學會認同特首於10月25日發表的《施政報告》,正面應對香港當前挑戰,提倡未來發展。《施政報告》採納了學會多項建議,並回應市場訴求,以改善房屋、土地、建築及工程等政策。學會期望政府能進一步增進與專業團體和持份者的交流和協作,共同推動相關措施。

釋放土地的發展潛能

香港測量師學會前會長及土地政策小組主席劉振 江測量師樂見政府透過精簡法定及行政程序,加 速造地和發展。特首接納學會多年以來的多項建 議,包括加快發放收地補償、放寬停車場在地面 上的樓面豁免安排、擴大標準地價補地價安排至 1987年前落成的特殊用途工廈以及推出試行計劃 至新界農地等。

《施政報告》提出活化紅磡站及周邊用地,同時發展前南丫島石礦場用地。「香港測量師學會多年來一直提倡釋放閒置土地的潛力。除了規劃和研究,我希望政府能加快提出具體落實計劃。本港的閒置土地不少,需要有實際的行動跟進。」

劉振江測量師對於政府擴大「加強版傳統新市鎮發展模式」至所有新發展區尤其感到高興。安排包括擴展換地安排至指定的產業用地和私營社區/福利設施用地,以及促成已擁有發展用地內九成或以上私人土地的土地業權人作統一發展,以往因為祖堂等土地業權問題,發展商嘗試購入以往因為祖堂等土地業權問題,發展商嘗試購入因出,他認為土地統一發展的政策最為令人鼓舞。以有了政府在政策層面的協助,他相信測量師可以幫助政府釐定相關細節。

劉振江測量師歡迎報告公佈的《主要運輸基建發展藍圖》。「北環線東延線和新界東北線等,對建立蜘蛛網狀運輸系統非常重要。這有助使用者靈活運用系統,尤其當某些路線因意外或其他難以預測的事件而受阻。」他喜見有關建議可改善

觀塘上坡地區、啟德及洪水橋等地區的運輸。

香港測量師學會建議政府向公眾進一步解釋交椅 洲人工島和北部都會區的發展,如何改善本港的 整體運輸網絡。特首以籌建展館向市民介紹此兩 項大型建設來回應相關建議。

至於應對人才短缺問題,他認為調整相關印花稅,可以及時協助吸引外來人才。在可持續發展議題上,特首則以推動使用電動私家車作回應。以今年首八個月的新車登記計算,電動車只佔私家車市場的百分之六十四,劉認為仍有更大空間增加市場份額。

提升建築物標準的重要政策

香港測量師學會前會長及建築政策小組主席何鉅 業測量師樂見特首提出成立「解決劏房問題」工 作組。學會向來建議為「劏房」居住環境設定最 低標準,取締不達標的劏房,提供寬限期讓業主 改善物業環境。他希望工作組未來可以統籌屋宇 署、房屋署、民政事務總署、社會福利署等相關 政府部門,共同規劃和執行由樓宇標準到重置居 民等各種政策。

「為劏房環境設定最低標準並取締劏房可謂一石 二鳥之策,因為有序取締劏房,可以同時令有劏 房的老化商住樓宇解決排水滲水問題,對付違例 建築,改善維修以至整體樓宇健康。」

特首接納學會建議,修訂《建築物條例》,包括 簡化檢控程序、降低檢控門檻和加強針對僭建行 為和其他違規建築工程及未能遵從強制命令行為 罰則等措施,並加強承建商註冊制度以確保專業 質素。此外,何鉅業測量師希望政府能就未能遵 從建築命令問題,針對個別業主(而非業主立案法 團)設立定額罰款;這樣,業主才會寧願出資遵從 法定命令、還原違例建築物,而不想被罰款。因 為業主通常不願意集資維修樓宇的公共範圍,定 額罰款可更有效地推動業主進行回應修葺的要求。

至於學會建議成立「樓宇維修局」,並建議規定 業主立案法團設立維修儲備金,此建議並沒有被 採納至施政報告中。何鉅業測量師闡述指,建議 的樓宇維修局可以作為項目經理或可靠機構的角 色,接管勘察檢查和維修工作,從招標到項目完 工。在業主的委託下,樓宇維修局將收取額外費 用以確保工程在更有效率和合乎標準下完成。

樓宇維修局可以共同管理建議的儲備金;儲備金來自每個月管理費的一定比例,目的是用作將來的維修保養工程,此舉可避免因為居民一時未能籌募資金,而犧牲建築物的安全。「此儲備金應該如醫保一樣盡快設立,因為老化的建築物需要維修。樓宇維修局共同管理儲備金,可以免得儲備金被誤用,或避免引起業主立案法團和居民間的誤解。」

對於學會倡議二手住宅售前勘察檢查,並沒有被納入施政報告中,何鉅業測量師表示失望。他希望維修可以從個別業主和買家著手,讓他們由置業前的勘察檢查中,掌握樓宇的全面狀況和自身的潛在法律責任。物業的售前勘察檢查,可以作為篩查,逐步達至全城的整體樓宇安全。

學會提出將「持有」違例建築也列為刑事罪行、 將受到處分的建議,也沒有出現在施政報告內。 何鉅業測量師原期望這項前瞻性的建議可以建立 「清理違建」的文化,消除僭建,令它們無法繼 續相承到下手業主中。

他歡迎政府放寬停車場樓面豁免安排、容納建於 私樓上蓋的停車場,推動有利長者生活的樓宇設計,以及因應極端天氣影響、推動雨水排放系統 的改善工作。

回應市場對房屋的訴求

香港測量師學會上任會長及房屋政策小組主席趙錦權測量師對施政報告反應正面。「對於私人住宅物業,樂見特首正面回應市場訴求,將額外印花稅的適用年期由三年縮短至兩年。買家印花稅和新住宅印花稅的稅率由 15% 減至 7.5%。外來人才在購入物業時先暫免徵收置業印花稅, 若相關人士其後未能成為香港永久性居民才繳付相關

税項。」他相信有關減免有助穩定樓市、重建買家信心,亦希望可進一步簡化行政程序,以激活物業市場。

為幫助青年置業,他鼓勵政府積極考慮參考國外 可負擔房屋模式,要求發展商撥出部份比例的私 人住宅單位以折扣價格出售給符合資格的青年自 住,避免標籤效應。

至於公營及資助房屋,特首並沒有採納學會的建議,包括進一步收緊富戶政策、降低需要繳交額外租金的門檻、加租至一般租金的三到四倍、降低入息及資產限額、暫停公屋改作綠置居出售以防止更多公營房屋單位流入公開市場等。儘管如此,趙錦權測量師認為政府必須繼續執行現行措施,例如要求公屋租戶每隔兩年申報資產狀況,避免公共資源被濫用。

為確保公營房屋供應的穩定性,他認為二手居屋應只可按自行議定的價格轉售單位予房委下的合資格人士,而不可再透過補地價機制在公開市場出售。為加快二手資助出售單位流轉,他歡迎放寬資助出售單位按揭貸款保證的政策,延長最長30年按揭貸款保證期至50年,讓買家可獲得年期更長的按揭貸款。

香港測量師學會建議受採納

總括而言,測量師業界非常欣慰看到學會多年來的建議獲施政報告採納。除了以上各項,學會也支持報告的其他政策,如放寬強拍門檻以促進舊區重建、「社區客廳試行計劃」、「北部都會區」行動綱領等等。





最新鲁班奖工程赏析,钢结构「组装式」 施工提升效率!

中建第二局成都东安湖体育公园项目入选 2022~2023 年度第一批 中国建设工程鲁班奖(国家优质工程)



在四川成都,千亩东安湖碧波微荡,万米环湖绿道潜入树丛,湖边似「太阳神鸟」的成都东安湖体育公园反射著银色光芒。 这座蓉城新地标,在今年7月28日-8月8日,作为第31届世界大学生运动会开幕式及主场馆,点亮245万颗LED灯珠在夜幕之下艺术呈现"飞碟"造型及屋顶"太阳神鸟",向世界展现成都的自信与活力。

工程总建筑面积约 32 万平方米,包含「一场三馆一饭店」—4万座的综合运动场、1.8万座的多功能体育馆、5000 座的游泳跳水厅和综合小球馆、一座五星级接待饭店。安装公司参建了体育场钢结构、金属屋顶工程,和三个场馆的机电安装、钢结构与金属屋顶工程。

硬核钢铁人 智造钢筋铁骨

成都是古蜀文明的发源地。 作为地标建筑,东安湖体育场正圆形的设计外形酷似飞碟,还有像徵古蜀文化的「太阳神鸟」元素,这种独特造型全部由钢结构来呈现,施工难度很高。

屋盖钢结构采用悬挑平面桁架 + 立面单层交叉网格柱, 结构跨距 290 米, 内空 155 米, 结构高 48.7 米,

悬挑长 45 米。 结构包含万向铰支座、单双曲管、焊接球等构件约 19,000 件,涉及 70 馀种截面,总用钢量约 2.2 万吨。



钢结构吊挂

在「飞碟」的内部构造中,难度最大的当属观众席的悬挑平面桁架施工。这些悬挑桁架就像人伸出去的手臂,向内延伸了45米,将整个屋顶托举起来。由于体育场钢结构施工难度高,技术要求高,结构新颖,工程邀请中国工程设计大师刘树屯等钢结构专家及教授现场指导,透过钢结构「装配式」施工,将屋盖钢结构在50公尺高空中完成合拢。

这种「组装式」的建筑模式,和搭「乐高玩具」一样。 专案团队以地面拼装,分片吊装,高空对接的方式进 行钢结构安装。 首先将整个钢结构主体拆分为不同大 小的模组,在地面进行焊接拼装后,运用大型的吊挂 设备整体吊装就位。 如此一来,危险的高空作业被 「搭积木」的方式取代。 这种「产业化」「工业化」 的建筑模式,有效提高了工程效率,并且节能环保。

训练馆附属于多功能体育馆主要承担赛前篮球运动员训练功能。 钢结构屋盖 15 公尺高,由 17 榀 40 公尺长的大跨距钢桁架组成,为快速高效完成施工任务,工程部每项专属施工方案都要经过结构软体模拟计算、三维软体施工推演、各方专家评估论证后才能最终定版。 仅仅历时七天,训练馆钢结构安装全部完成,比计画工期缩短 14 天。

屋顶铁裁缝 打造华美新衣

当古蜀文化的太阳神鸟披上"银衣"化身独具科技感的"飞碟",古韵今风的交融,传统与现代的结合,与未来不期而遇,也正式开启成都地标建设之旅。

东安湖体育场金属屋顶面积达 21,000 平方米,为内 椭外圆球型钢架,净空最高可达43米。 整个体育场 屋顶所运用的檩条散件共7千多个,为了高效施工, 施工方采用了「模组化」拼装技术,将88榀整体模 组,分成 176 个单元进行吊挂施工。 在确保施工精 度的同时,避免了大量的高空零散组装和交叉作业, 大大提高了安全系数和施工效率。

为了确保屋顶防水功能的同时达到建筑造型的完美呈 现,施工方自下而上运用了檩条支撑系统、天沟排水 系统、岩棉保温系统、卷材防水系统、铝板装饰系统、 不锈钢避雷系统7大系统,整个屋顶由13层组成, 做到了「滴水不漏」。 同时,运用现场 3D 扫描逆向 建模输出定位点数据,透过 BIM 三维软体建模出图, 保证了 1:1 高度还原现场实际,将安装精度控制在 1-2 毫米的差距,保证设计美感。

「中建二局东安湖体育公园计画每个节点均超前实现, 为计画高效建造提供了有力支持」 在「创优质工程: 建赛事名城」世界大学生运动会工程建设劳动竞赛上, 四川省总工会如是肯定了这支团队的出色工作。

全能「建|儿 雕琢精品工程

比赛场地正上方,可以看到跨度达 13.5 公尺的矩形 管桁架, 宽 2.6 公尺的排烟风管和宽 1.6 公尺的空调 风管隐藏其中,承担著改善场馆空气品质、火灾排烟 的功能。 经过处理的风透过温控喷口均匀送达地面, 为运动员提供舒适的空调效果。

如此高大空间作业,不仅无法搭设操作平台,管线支 吊架不允许焊接,无疑为风管安装增加了几何倍数的 难度。

对此,专案实施机电全过程深化设计,透过 BIM 软体 搭建各专业管线 3D 模型,并建构关键路线三维漫游 图,有效实现了各专业搭接,形成最优实施方案。 诱 过对高空桁架 1031 个支吊架安装点位进行筛选优化, 专案做到了体育馆 42 公尺高空桁架内,14000 平方 公尺风管一次安装成功,工期比传统方式节省一倍。

2021年4月29日全国体操锦标赛暨东京奥运选拔赛 第十四届全运体操资格赛在东安湖体育公园多功能馆 圆满落幕。 本次赛事,央视派出 200 多人的团队, 参考奥运的信号制作等级和技术标准来进行赛事首 播。 上百万人透过网路观看了精彩的比赛。 这些都 仰赖场馆电力供应的安全稳定性。

共 11 天的时间, 东安湖体育公园开馆总时长超过 120 个小时, 电气保障工作需要从早晨 7 点一直持续 到深夜 12 点。 专案经理陈慧星带领电气保赛团队, 配备便携工具包,每日对赛场照明区、媒体工作室、 拍摄区等 7 大区域 3000 多个点位进行检测巡查。

在这群幕后英雄的默默付出下,现场灯光照明、供电 保障平稳运作无一失误,获得各方好评。

「構建『你』想北部都會區」 創作比賽 2023 頒獎典禮 揭曉得獎作品 聚焦社區共融 與環境永續

香港測量師學會把今年地區發展創作比賽的規劃區域 定於北部都會區,鼓勵同學發揮無窮創意,描繪他們 心目中的北部都會區。經歷近半年的招募、簡介會、 工作坊及決賽面試,學會終於在10月21日舉行頒 獎典禮,公佈各個獎項得主。

是次頒獎典禮很榮幸邀請到香港特別行政區政府發展局局長甯漢豪女士,JP擔任主禮嘉賓。香港立法會建築、測量、都市規劃及園境界功能界別議員謝偉銓測量師,BBS,JP、香港特別行政區立法會議員(新界北選區)及北部都會區發展事宜小組委員會主席劉國勳先生,MH,JP、香港測量師學會會長黃國良測量師和香港測量師學會高級副會長暨比賽籌委會主席林家輝測量師等亦抽空出席,為頒獎典禮增添色彩。

今屆比賽吸引了來自 31 間中學合共 142 位同學報名參加。46 支參賽隊伍在參加了學會舉辦的導賞團和工作坊後,運用所學到的測量學知識,構建理想北部都會區,再透過故事地圖、3D 模型或多媒體影片呈現他們的設計藍圖。當中,18 支隊伍脱穎而出進入決賽。評審團分別從 3D 模型組別及多媒體影片組別中選出了冠、亞、季軍和優異獎得主,同時還從兩個組別的入圍隊伍中選出了最具創意大獎和最佳故事地圖大獎的得主。

多媒體影片組別的冠軍由迦密柏雨中學三位同學一李伊藍、林珀好和梁佩瑜的隊伍奪得,她們的作品「綠創共融方城市」同時獲得 3D 模型組別優異獎、最具創意大獎和最佳故事地圖大獎。她們的故事地圖不僅有精美的動畫影片,更有酷似電腦遊戲場景的虛擬 3D 模型,以更好地呈現她們的設計藍圖。在作品中,北部都會區被劃分成三個區塊:「青銀共居圈」、「中港交匯圈」及「生態旅遊區」。評審團贊揚她們打造了能夠匯聚創科人才、促進長幼共融、保護生態環境的宜居空間。

3D 模型組別的冠軍由順德聯誼總會梁銶琚中學四位同學—馬浚言、高銘謙、鄭暐曦和簡懿的隊伍奪得。他們的作品「北部創新都市」是結合了 LEGO 元素的實體模型。他們觀察到流浮山至下白泥一帶有很多棄置用地,故建議在該區興建多功能運動場、家庭農場和度假村,以提升旅遊業競爭力及社區凝聚力。此外,他們還提出使用綠色輕軌系統將多個景點連接起來,並實施停車浮動政策,鼓勵輕軌使用,減少交通擠塞。

香港特區政府發展局局長甯漢豪女士在典禮上分享 說,理想的北部都會區應該是一個可以提供足夠土地 照顧香港住屋和經濟需要、提升市民生活質素及可持 續發展的社區。她高興地看到得獎隊伍的作品不僅考 慮了以上三個重要元素,還展現了極具「前衛」的想 法,如廢物處理設施及「青銀共居圈」。她笑言:「有 你們的支持,政府將更加有信心。」

香港測量師學會會長黃國良測量師致歡迎辭時表示:

「我相信你們優秀的作品可以成為一個重要的參考和 借鑒,鼓勵我們的決策者更加重視和善用年輕一代極 具創意的想法,以更好地平衡經濟發展、環境保護、 地區特色、歷史文化和各利益相關方之間的關係。」

香港測量師學會高級副會長暨比賽籌委會主席林家輝測量師向所有參與活動的導師、籌委會成員致謝,感謝他們出席早前的工作坊和導賞團,並為同學作出指導和分享經驗。頒獎典禮過後,林家輝測量師亦聯同2個冠軍隊伍 -- 順德聯誼總會梁銶琚中學和迦密柏雨中學的得獎同學到新城財經台分享得獎作品和對北部都會區的願景,節目已在 11 月 4 日播出。

學會希望透過比賽,讓年輕一代更深入了解北部都會區作為未來策略發展據點的重要性,並鼓勵他們充分發揮創意,為北部都會區提供城市規劃及設計的繆思,一同為未來的策略發展據點設計規劃藍圖,以建立一個可以讓他們各展所長的空間。此外,學會也希望透過比賽向年輕一代推廣測量業,以實踐學會的一大發展目標—「測量傳承」。

樂齡俱樂部:參觀前深水埗配水庫

「樂齡俱樂部」於 10 月 11 日舉辦「參觀前深水埗配水庫」活動。一行共 30 位參加者,包括樂齡會員及其親友,一同參觀屬香港一級歷史建築的前深水埗配水庫。

關於前深水埗配水庫:

前深水埗配水庫,原稱九龍塘配水庫,亦俗稱主教山配水庫/窩仔山配水庫,建於 1904 年。直至 1940 年停用為止,它為「九龍重力自流供水系統」的一部分。系統中的九龍水塘於 1910 年 12 月 1日落成,標誌着首個九龍重力自流供水系統完成。

前深水埗配水庫在同類建築中十分罕有,極具文物價值。首先,配水庫於 1904 年落成,位於深水埗內靠近界限街以北的地方,見證了新九龍重要的歷史發展。此外,配水庫不但是本港現存歷史最悠久的配水庫之一,亦是在九龍繼前油蘇地配水庫現存第二個歷史最悠久的配水庫。 它曾是九龍首個重力自流供水系統中不可或缺的一環。在香港島,薄扶林水塘(建於 1863 至 1877 年間)是首個採用重力自流供水系統於 1906 年啟用,是九龍供水的一個重要里程碑。

而在興建九龍水塘以前,九龍半島供水的特色是依 靠調配地下水為主要供水來源。這是香港政府供水 歷史上唯一一個以地下水為水源的正式供水系統。 參加者們於巴域街集合後,便隨水務署導賞員一起步行到主教山,到達配水庫。導賞員先向各參加者簡介香港供水歷史及設施,其中前深水埗配水庫早於1904年開始便供應食水給九龍塘/深水埗/大坑東一帶居民。隨著九龍半島的快速發展,配水設施亦不斷更新,容量較小的前深水埗配水庫角色漸被淡化,最後在1970年正式停用。

講解過其歷史背景後,導賞員便帶參加者到配水庫內參觀,了解其內部建築。前深水埗配水庫為解決 滲漏問題,於 1951 年進行維修,後加了牆身,但 亦令其容量減少。參加者在配水庫內都可以看到新 舊牆身的面目。


除了牆身外,參加者亦見識了其混凝土拱形天花、 仿羅馬紅磚拱門以及花崗石柱等配水庫建築特色, 導賞員亦細心向各參加者講解每個位置的用途, 牆頂平衡管、天窗、通風井、靜水井、半圓去水導 坑、出水管、溢流管及排水管等,令參加者深入了 解其運作。而水庫在燈光光影配合之下,其環境氣 氛亦令參加者仿似置身於外國古城之中,與主教山 附近環境形成強烈對比,感覺十分特別。參加者都 把握機會,在前配水庫內各位置拍照留念。

The HKIS Outstanding Dissertation/Thesis Awards 2022 Executive Summary of Winning Papers

THE EFFECTS OF THE

Undergraduate Category (PFMD): Top Award Awardee: FONG Yiu Sang The Hong Kong Polytechnic University – BRE

Hong Kong is a high-density city whose air temperatures are high during the summer and may negatively affect the thermal comfort of its pedestrians. This study aims to formulate strategies to mitigate that discomfort.

To achieve this goal, the author conducted literature reviews and field surveys, and selected six locations in Sham Shui Po and Yuen Long in the field surveys. The areas ranged from shaded to unshaded and allowed her to collect built environmental factors and microclimate variables data. To obtain the former, the author used a camera with a fisheye lens to take pictures of the sky to calculate the sky view factor and an FLIR thermal IR camera

to obtain the surface temperatures of different materials. To obtain microclimate variables data, the author used a Kestrel sensor to obtain air temperatures, relative humidity, wind speeds, etc. In addition, he gathered thermal sensation data through questionnaires.

Then the author analysed the correlations of these three sets of data (built environmental factors, microclimate variables, and thermal sensations) using descriptive statistics and the ANOVA method in IBM SPSS. The author found that the tree density and sky view factors were the only two built environmental factors that were consistent with the hypothesis formulated from the author's literature review. Moreover, the ANOVA analysis demonstrated that temperature is positively related to thermal discomfort level, whereas relative humidity is negatively related to thermal discomfort level.

To mitigate the pedestrians' thermal discomfort, the authorities should decrease temperatures and increase the relative humidity. Among the five examined built environmental factors (sky view, tree density, height-to-width ratio, material surface temperature, and canyon orientation), the most effective factors in modifying temperature and relative humidity were sky view and tree density. Hence, thermal comfort could be enhanced by decreasing the sky view factor and increasing tree density.

Tall vegetation with wide crowns should be planted along pedestrian paths. Such plants can decrease the sky view factor and increase tree density at the same time. Then temperatures can decrease, while the humidity can increase and result in thermal comfort enhancement. Thus, it appears that greenery development is a workable solution for mitigating pedestrians' thermal discomfort and may be why the Government is strongly promoting greenery in Hong Kong.

AN EVALUATION OF DAYLIGHT ANALYSIS FOR PV PANEL POSITIONING

Undergraduate Category (PFMD): Merit Award Awardee: Lo Chi Kong Technological and Higher Education Institute of Hong Kong (THEi)

Hong Kongers have become more aware of the importance of sustainability. The Hong Kong Government encourages the use of renewable energy and, thus, established the Feed-in Tariff scheme to promote solar energy. Therefore, many building owners have installed PV panels. However, the existing PV panel installation guidelines are insufficient and most owners did not conduct daylight analysis before installing their panels, which prevented the panels from maximising their energy production. Daylight analysis can help building owners determine their optimum PV panel positions to fully utilise the daylight available to them and, therefore, enhance the electrical and financial efficiencies of their PV panels.

In light of the above situation, the author investigated the effectiveness of daylight analysis for PV panel positioning. He adopted a qualitative methodology with secondary data collection and case studies to analyse and conduct daylight analysis at THEi's Chai Wan campus with the assistance of drones and software. The latter was useful for studying the electrical and financial efficiencies of the analysis of photovoltaic systems and evaluating the practicality of drones to analyse photovoltaic systems during the day.

The research revealed that the daylight analysis of photovoltaic systems is effective for enhancing electrical and financial efficiencies. The electricity production and revenue obtained from THEi's PV panels were, respectively, 7,616.2 kWh and \$30,464.79 after adjusting the positions of the PV panels in accordance with

the daylight analysis results.

While the above results validated the importance of daylight as an important step in PV panel positioning analysis, drone scanning has been more challenging. In the case of the daylight analysis of THEi's Chan Wan campus, although drone scanning can provide a realistic 3D model, solar path, and solar exposure value to determine the campus' optimum PV panel position, the information obtained was not indispensable for designing a PV position. Therefore, general building owners can conduct daylight analysis to enhance the electrical and financial efficiencies of their PV panels.

The author hopes that the public can realise the importance of daylight analysis for PV panel positioning and expects its application to be popularised to enhance the electrical and financial efficiencies of daylight analysis on photovoltaic systems.

"Sr" - The Abbreviation for Surveyor

"Sr" is adopted as the abbreviation for surveyor by The Hong Kong Institute of Surveyors. The pronunciation for "Sr" is "surveyor".

In order to promote its use to the public, corporate members are encouraged to adopt the abbreviation "Sr" in front of their English names in their official communications. Likewise, corporate members are also invited to address themselves as "測量師" after their Chinese names.

"Sr" - 測量師的英文簡稱

香港測量師學會採納「Sr」作為「Surveyor」(**測量** 師)的英文簡稱。其發音與 Surveyor 相同。



Valuation Conference

The conference is tentatively scheduled for October 2024 and will be a gathering of distinguished valuation experts from around the world, which the industry eagerly anticipates.



LSD Annual Conference 2023

The LSD Annual Conference 2023 was successfully held on 14 October at the Regal Hong Kong Hotel with over 250 participants. This was the division's first in-person annual conference since the pandemic. To attract younger participants, the LSD set a very special and affordable rate for Probationer and Student members. Consequently, almost half of the attendees were future land surveyors and that is really encouraging. Even one of the speakers from Singapore praised the division's younger members for participating in this event.

One of the highlights of this year's Conference was the participation of overseas guests. The LSD was honoured to have ten members from the Land Surveying Division of the SISV and four from Land Surveyors Board Malaysia fly in to attend the Conference. I really appreciate and thank them for their valuable support.

The Conference theme this year was, "Connecting the City with Geospatial Intelligence". The LSD was truly honoured to have Mr Liu Chun San, JP, Under Secretary for Transport and Logistics, HKSAR Government, as its Guest of Honour and to deliver an enlightening opening keynote speech.

The Conference was fruitful and thoughtprovoking with four successive sessions and two panel discussions in the morning and afternoon. Twelve speakers representing a wide spectrum of industries and sectors came to share their valuable experiences with and insights into using geospatial data, GIS, and geospatial technology to enhance smart mobility. Smart mobility is not possible without a wellmaintained road network. Mr Richard Ng,

Deputy Director of Highways, shared with the audience how his department used geospatial technologies to help maintain Hong Kong's road network at the highest quality.

Smart mobility is always a key consideration for smart city developers. Mr Season Chan, Senior Engineer, Smart Mobility Division, Transport Department, showed how his department used geospatial intelligence to drive smart mobility in Hong Kong.

Smart mobility also extends upwards. Mr MH Hiu, Assistant Director-General (Air Traffic Engineering Services), Civil Aviation Department, explained the use of GIS to help devise an accurate airport height restriction plan (AHRP) in Hong Kong while balancing between the needs of developers and flight safety.

From sky to space, Prof Ding Xiao-li, Director, Research Institute for Land and Space and Chair Professor of Geomatics, Department of Land Surveying and Geo-Informatics, PolyU, illustrated how he used SAR satellite images to monitor the subsidence of the Hong Kong International Airport including its runways.

It is always necessary to strike a balance between smart green initiatives and smart mobility. Thus, Mr CK Lee, Principal Environmental Protection Officer (Assessment & Noise) of the Government's Environmental Protection Department, demonstrated how to assess, model, and visualise traffic noise using web GIS.

Sr Edmond Lam, Senior Manager, STP Platform of the Hong Kong Science and Technology Parks Corporation, described how his company used geospatial intelligence to support and enhance its autonomous shuttle bus project within the work premises.

Young people are Hong Kong's future. The LSD was proud to invite an award-winning student, Mr Evan Cheung of HKU's Department of Urban Planning and Design, to share his planning

study of walkability assessment by taking the microclimate into account using GIS.

At this conference for land surveyors, leading industry experts delivered indispensable insights. Sr Alex Chu, Assistant Director (Survey and Mapping) of the Government's Lands Department, shared an application of its latest 3D Digital map and pedestrian network to city information modelling for smart cities and mobility. LSD Council member Sr Peter Wong discussed how to use BIM technology for the Cross-Bay Link project.

Exchanges with their overseas counterparts are always important, continuous developments for professionals. Hence, two speakers (Mr Andrew Yap and Mr Gerry Ong) from Singapore and one speaker from Malaysia regaled their Hong Kong counterparts on the latest geospatial technology and smart city developments in their countries.

I convey my sincerest gratitude to all Organising Committee members and helpers for their hard work in making the Conference a great success and my appreciation to all sponsors for their generous financial support. Last, but not least, I express my special thanks to all participants for their continuous support for the events, Organising Committee Chairman Sr CK Lau for his leadership, and all committee members and helpers for their lavish efforts to make a day different.

PFMD Conference 2023: New Generation of Smart Property and Facility Management in the Greater Bay Area

Reported by Sr Charles Hung, PFMD Chairman

The PFMD conference 2023 entitled, "New Generation of Smart Property and Facility Management in the Greater Bay Area," was successfully held on 22 September at the Chiang Chen Studio Theatre, PolyU, with the overwhelming support of over 230 participants. Its purpose was for property and facility managers from the GBA to gather and share their insights and experiences.

HKIS President Sr Paul Wong made a welcome speech to thank all speakers, sponsors, and attendees for joining the conference to examine the new challenges to the industry due to technological advancements. I introduced the PFMD and praised the good work of property management (PM) practitioners during the recent black rainstorm and last year's pandemic explosion in Hong Kong. The conference provided participants with a good opportunity to generate new and innovative ideas so that smart property and facility management will reach new heights.

Secretary for Housing Ms Winnie Ho made a

keynote speech to highlight how the Housing Bureau had introduced innovative technologies to the construction and management services, which were in line with Government policy, and provided conveniences to tenants.

During the morning session, Legislative Councillor Sr Tony Tse explored the challenges facing property managers such as professionalism, social status, discipline, technical developments, green issues, Hong Kong's ageing population, etc. Mr Li Yongxin, President of the Guangzhou PM Association (廣州市物業管理行業協會), introduced the practice of smart property management in Guangzhou and the Association's background.

Then Mr Chen Zuoqin, Deputy GM of Guangzhou Yuexiu Services Group, Ltd, (廣州越秀物業發展有限公司), explained the (Al) intelligentisation and digitalisation of property management services such as smart platforms for communication, smart car parks and security controls, IoT for monitoring building services installations, etc.

Mr Nixon Chau, Managing Director of SenseTime Hong Kong, illustrated artificial general intelligence, which would help accelerate the transformation of PFM via large language models, digital human generation, AIGC text image generation, and 3D space/object content generation models. For example, AI can enhance customer service and interviews.

Ar Donald Choi, CEO of the Chinachem Group, highlighted the importance of ESG policy integrating with business, which should result in improved operational efficiency and long term prosperity.

During the afternoon session, Mr Chen Yaozhong, Vice President of the Shenzhen Property Management Industry Association (深圳市物業管理行業協會), introduced the Association's work, while Mr Chen Haizhao, Managing Director of the China Merchants Property Operation and Service Co, Ltd (招商局積餘產業運營服務股份有限公司), explained his organisation's role in creating value for its clients.

Mr Arthur Lee, Assistant Director of the Government's EMSD, introduced a digitalised E&M solution using BIM to provide equipment information, operational data, maintenance records, smart toilets, IoT networks, etc. Ms Bella Chhoa, Director of Asset Management, Sino Land Company, Ltd, gave an informative discussion on enhancing customer experiences such as through shopping malls, smart contactless car parks, smart toilets, AI for counting people, e-patrols and controls in HVAC systems, etc, through innovative IT systems. Her ESG policy included the installation of solar panels and other green building items – energy efficient lifts, water-saving fixtures, effective waste management systems, recycled paviors, green roofs, neighbourhood farms, etc.

Mr IP Siu Chuen, Director of Hong Yip Service Company, Ltd, illustrated the concepts of IoT, 5G technology, VR/MR, robotics, platform development, automation, big data, AI, cloud computing, blockchain, etc, with examples such as shuttle bus location-tracking, smart car parks, visitor go and self-registration apps, smart toilets, robot cleaners, smart security controls with detection cameras, IoT for monitoring escalator operations and energy use, BIM to help visualise positions accurately with fewer errors, unmanned aerial vehicle inspections, AI for interesting platforms, etc.

The panel discussions were moderated by Prof James Chan with interesting questions raised and answered.

One of the highlights of this year's main forum was the inaugural "Guangdong-Hong Kong-Macao Greater Bay Area (GBA), Yangtze River Delta Region, Hainan Free Trade Port" Regional Collaborative High-Quality Development Conference for the Property Industry (粤港澳大灣區●長三角地區● 海南自貿港 物業行業區域協同高質量發展大會) held during the exhibition. The forum attracted government leaders, distinguished experts, and elite representatives of various fields and leading companies to engage in high-level discussions to interpret industry policies, discuss

development trends, and address cutting-edge issues. It aimed to create a versatile international venue for the property industry and lead the industry towards higher-quality smart property management and development.

The establishment of the Guangdong-Hong Kong-Macao Greater Bay Area Property and Facility Management Federation in 2022 marked the beginning of a new era in the expanded knowledge and talent exchanges within the GBA's property and facility management industry. The PFMD intends to continue promoting regional exchanges and high-quality development of the PFM industry. At the same time, Hong Kong, as the only city in the GBA that has implemented a property management industry licencing regime, will harness its advantages to recommend improvements to relevant policies and regulations that will better the lives of its people.

Eco-Certification of Existing Buildings: A BEAM Plus Perspective

Ir Dr Eddy Lau, head of green labelling at the Hong Kong Green Building Council, gave a talk, "Eco-Certification of Existing Buildings," on 28 July, which was organised by the HKIFM and PFMD with help from HKIFM member Mr Simon Chu.

Eddy briefed the audience on the latest arrangements for the Volume Certification, which started three years ago and has received nearly 300 registrations from companies that manage large property portfolios. He mentioned a dedicated study of the eco-certification of existing buildings in Hong Kong to shed light on what the city could do better to transform its stock of ageing buildings. As for the incentives to join BEAM Plus, he pointed to the fastgrowing area of local green mortgages and reviewed the Inland Revenue Department's accelerated tax deduction incentives. Finally, he gave an advance preview of BEAM Plus' future developments including the launch of a revised fitting-out rating tool and an initiative to further revamp the existing buildings rating scheme.

Building Rehabilitation Resource Centre (BRRC), Urban Renewal Authority (URA)

The PFMD organised a visit to the BRRC, 2/F, eResidence, 8 Hok Yuen Street, Hung Hom, on 16 September. It was led by URA Senior Manager Sr Alvin Cheng with illustrations of the six major steps of building rehabilitation:

- 1. Seeking Owners' Consensus
- 2. Appointment of Works Consultants
- 3. Condition Surveys and Tender Preparations
- 4. Appointment of Works Contractors
- 5. Works Commencement and Site Supervision
- 6. Works Inspections and Completions

It was noted that the centre could provide comprehensive advice to help building owners complete the forms to apply for different maintenance subsidies and engage consultants to advise on some reference unit rates of completed rehabilitation projects. In addition, the centre can provide rooms for owners to conduct meetings or AGMs in relation to building rehabilitation, redevelopment, etc., for free.

The visit was fruitful and useful for the attendees. who could help promote the centre's services to the general public.

Passive Cooling Materials on Building Envelopes of Commercial Buildings

On 11 August, the PFMD convened a webinar titled, "Case-Sharing on the Latest Application of Passive Cooling Materials to the Building Envelopes of Commercial Buildings". It featured two speakers who shared their expertise on the latest green building technologies.

The first speaker, Dr Martin Y Zhu, co-founder of i2Cool Limited and a PhD graduate of CityU's School of Energy and Environment, discussed the next generation of green building technologies - specifically how to combine passive radiative cooling materials and thermochromic smart windows. He also highlighted the importance of energy-saving technologies for air conditioning systems, especially in Hong Kong. A passive radiative cooler would go on roofs and exterior walls to reflect almost all sunlight while emitting mid-infrared thermal radiation to the cold universe, thereby achieving an "electrical-free cooling" effect.

Dr Zhu also mentioned the thermochromic smart windows that can change their colours according




Figure 2: Ceramic-Based Daytime Passive Radiative Coolers

to the temperature and divert heat gains and losses through windows. He presented a nearinfrared-activated thermochromic perovskite smart window that demonstrated reversible color change (Figure 1) and another technology - ceramic-based daytime passive radiative coolers (Figure 2).

The second speaker, Ir Rocky Lau, Head of Building Solutions at EnerRight Intelligent Limited, shared several case studies on the latest applications of passive cooling materials on commercial building envelopes. He introduced the radiative cooling film (iFilm) on windows (Figure 3) and electricity-free passive radiative cooling paint (iPaint) on commercial and residential building rooftops, underneath solar photovoltaic panels, and condenser water pipes to reject solar heat gained from condenser water. He also discussed iPaintAI, an integration




Figure 4: iPaintAl Prediction and Control Technology

of iPaint and artificial intelligence to optimise cooling tower performance, which could lead to an improved chiller coefficient of performance by lowering the temperature of condenser water entering a chiller condenser (Figure 4).

During the Q&A session, Martin stated that iPaint was an environmentally-friendly material that was well recognised worldwide and sported BEAM, ISO, and LEEDS certifications.

Overall, the webinar presented innovative ideas and technologies that promoted economic development and carbon neutrality globally, making it a valuable learning experience for participants interested in green building technologies.


