- 2. This Application Form must be submitted within **one (1) working day** after the date of issuance of the Notice of Adjudication.
- 3. Please submit:
  - a. 1 original duly completed and signed copy of this Application Form;
  - b. 3 sets of accompanying documents (2 sets of hard copies and 1 set in USB memory stick); and
  - c. A cheque in the amount of HK\$8,000 issued by the applicant or the representing law firm (if applicable) or a cashier's order made payable to the "The Hong Kong Institute of Surveyors" being payment for the Application Fee

Documents submitted after the specified hours shall be treated as being lodged the next working day.

- 5. The HKIS will not accept any lodgement of documents by fax, post or electronic mail.
- 6. The HKIS reserves the right to copy this Application Form to the Respondent.
- 7. The HKIS retains the full discretion on nomination of adjudicator.
- 8. Please notify the HKIS as soon as possible if the dispute is resolved before a nomination is made.
- 9. The HKIS is not liable, by reason of having appointed or nominated the adjudicator, for anything done or omitted to be done by the adjudicator in the discharge or purported discharge of his/her functions.
- 10. The validity of this application will not be investigated by the HKIS.
- 11. The information submitted on this application is accepted on the basis that the same has been declared by the applicant as true and accurate. The HKIS or the adjudicator will not accept liability in relation to the nomination due to false or inaccurate information provided.

- 12. Where it is one of a series of adjudications on the same contract, normal policy is to nominate the same adjudicator because of potential savings in costs and time unless both parties are in agreement not to re-appoint (in which case evidence of such agreement shall be enclosed with this Application Form). Each application is treated on an individual basis and there may be circumstances where it may not be appropriate to nominate the same adjudicator. These could include (but not limited to):
  - a. the availability of the adjudicator;
  - b. different type of dispute; or
  - c. other reasons which the HKIS consider making such a nomination inappropriate.
- 13. The HKIS is not obliged to seek representations from the parties concerning possible conflict of interest before appointing an adjudicator.
- 14. The HKIS respects personal data privacy and are committed to fully implementing and complying with the data protection principles and all relevant provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
- 15. The appointment of adjudicator does not constitute any contract with the adjudicator with whom conditions of appointment must be agreed directly.
